



PRIVATE PAY AGREEMENT: LIFE PLANNING & FAMILY SUPPORT

Futures Explored provides support and training services for adults with physical and developmental disabilities. The Life Planning & Family Support Program provides support for families to plan for the healthy aging of their disabled family member, and for all members of the family, from the first transition to adulthood through the transition into old age.

BASIC SERVICES:

Futures Explored offers a variety of services and supports to help individuals and their families to develop a concrete plan for the individual's life. There are two outcomes that each family will accomplish. The first is a *Portrait of the Individual* and a *Letter of Intent*, which is used as a basis to help guide decisions, deal with crises, and help the individual to create and maintain a good life in their community as they move through the aging process. The second outcome is the development of a Support Network which will carry out the *Letter of Intent* for the individual with the disability after parents pass on or are not able to support their son/daughter.

Private Pay Services may consist of any and/or all of the following:

- * The standard Regional Center program of group workshops, individual support, and consulting to develop a Portrait of the Individual, a Letter of Intent, and a Social Network.
- * Specific-area consultation, for families who wish to move at their own pace and feel they only want help in certain areas.
- * Expanded Social Network opportunities, using the TYZE Network Software to build a Personal Support Network for the individual at the center of the Social Network.

PAYMENT FOR SERVICES: The following are the current charges for Private Pay Individuals:

- * \$250 Registration Fee: This one-time fee is required to start the program, and includes the complete Life Planning workbook and electronic copies of forms.
- * \$30/Hour Fee: Individuals wishing to participate in the standard Life Plan program of workshops, individual support, and social network development will be charged \$30 an hour for all services delivered (including face to face meetings, emails and phone consultations).
- * \$30/Hour Fee: Individuals simply wishing to receive consultation as they need it to complete the program will be charged \$30 an hour for all services delivered (including face to face meetings, emails and phone consultations).
- * \$30/Hour Fee: On-going support for individuals who have completed their Regional Center funded hours will be charged \$30 an hour for all services delivered.
- * \$15/Month Fee: TYZE Network support cost is \$15 per month.

BILLING: Futures Explored will bill each month in arrears for all services delivered during the month and expects payment within 30 days of billing. Futures Explored reserves the right to charge interest of 12% on all bills not paid within 30 days of issuance.

REFUND POLICY: Services are billed as provided.

AGREEMENT: Futures Explored wants applicants for the Life Planning & Family Support program to be successful, and therefore requires that the family and consumer sign the regular Admission Agreement.
